We will then delete your Information within 14 days. Google Tag Manager does not collect personal information. This tool enables the integration and administration of our tags. Tags are small pieces of code that we use to measure traffic and visitor behavior, to record the impact of my online advertising, or to test and optimize my websites.

Security

Purpose

Insights and complaints
